CDBG funds will be used for the following single family and multi-family rehabilitation activities: • City of Brea Single-Family Housing Rehabilitation – Funds will be used for rehabilitations to single-family low/very low income owner-occupied residents. Improvements will include interior and exterior improvements to homes and mobile home units. • City of Cypress Single-Family Housing Rehabilitation Program - Funds will be used to support the Home Enhancement Program or HELP II, which provides forgivable loans to income eligible homeowners in order to assist them with home improvements. • City of Laguna Woods Phase X Energy Efficiency Improvement Project – Funds will be used to provide energy efficient improvements to multi-residential units owned and occupied by very low-low income seniors. • City of Seal Beach Leisure World Bathroom Accessibility Program - Funds will be used to provide grants to income qualified, disable seniors to improve bathroom accessibility and safety by converting the tub/shower into accessible shower • County of Orange Neighborhood Preservations Program (NPP) - Funds will be used to provide stall. single-family rehabilitation loans and grants to income-qualified individuals residing in the County's unincorporated areas and participating cities. • City of Placentia Housing Rehabilitation Grant Program – Funds will be used to assist low and moderate-income qualified homeowners residing in single family residences or mobile homes. The program is designed to replace roofing, ADA accessibility, energy efficiency improvements, window replacement, painting and graffiti removal from private properties. • City of Yorba Linda Neighborhood Improvement Program – Funds will be used to provide rehabilitation grants to qualified homeowners for general property improvements and repairs to meet local codes, standards and ordinances.
